5. Process

- I stage; accepting applications online (via email or phone) until 31/07/2024
- II stage; announcement of performers and program of the concert on 7/08/2024
- III stage; rehearsals for final song (all performers required) 16/08/2023-17/08/2023 (2 rehearsals)- time and place will be specified and adapted to the artists availability.

6. Conditions for participating artists

- The concert is intended for soloists and ensembles, the condition for participation in the concert is the registration of the participants by;

- Filling in and sending a scan of consent attached to the application form, as the expression of consent is voluntary, however, failure to express any of the consents attached will make it ineligible to take part in the concert.
- Sending the "registration card" is tantamount to acceptance of the content hereof regulation.
- Participation in the concert is FREE.

Organizational Rules

- 1. Participants qualified to participate in the concert, will grant the concert organiser permission, in the form of a statement attached to the application forms, to disseminate their images in various forms of media, press, television, film, radio, etc.
- 2. Participants qualified for the concert will transfer free of charge, to the organisers (Zwiazek Polakow Melbourne) the rights to registration of works and artistic works performed during the concert. As all musical numbers performed will be filmed by the public.
- 3. Participants of the concert are obliged to use artistic works and performances with respect for the copyright or related rights of the original authors, performers and producers.
- 4. Matters not included in the regulations are resolved by the Director of the Concert, in consultation with the relevant arts committee.
- 5. Lyrics of songs used in the concert are not to contain vulgar, offensive, discriminatory or racist words/phrases/ intent.
